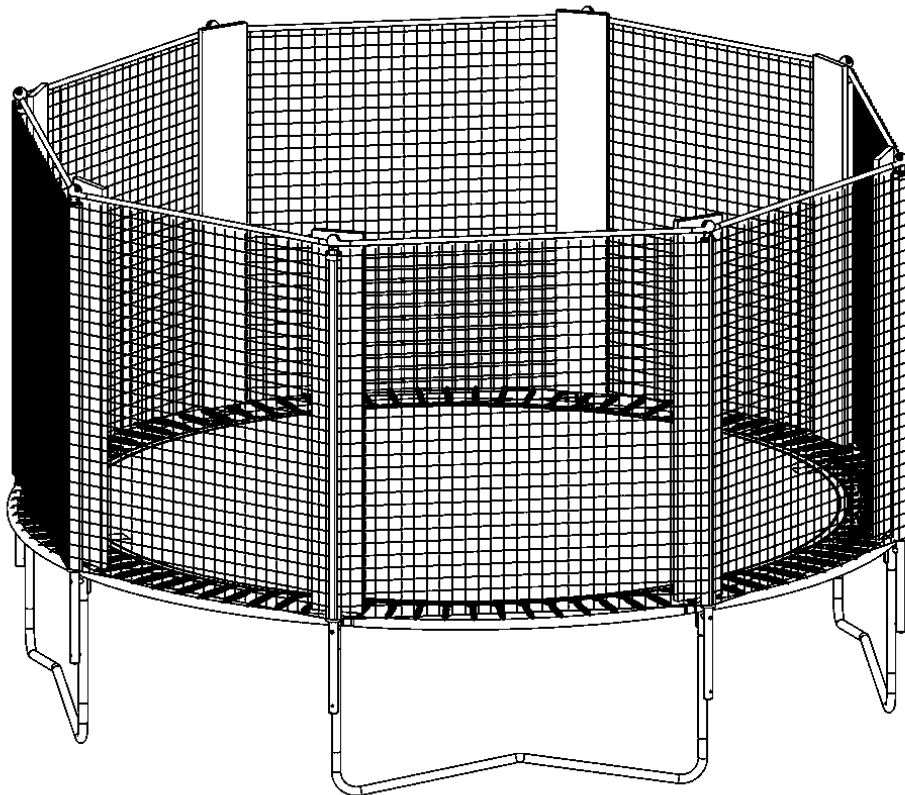

NOTE: Product shown with spring padding removed for clarity. Only use your AlleyOOP MMA Octagon System with net and padding completely installed.

- Trampolines over 20 inches (51 cm) tall are not recommended for use by children under 6 years of age.
- Use only in a well lit area by responsible, mature, non-intoxicated persons.

- Inspect before each use. Make sure the vertical pads are properly installed, and that all additional frame and pole padding on your trampoline and enclosure is correctly and securely positioned. Replace or adjust any loose, worn, defective, or missing parts.

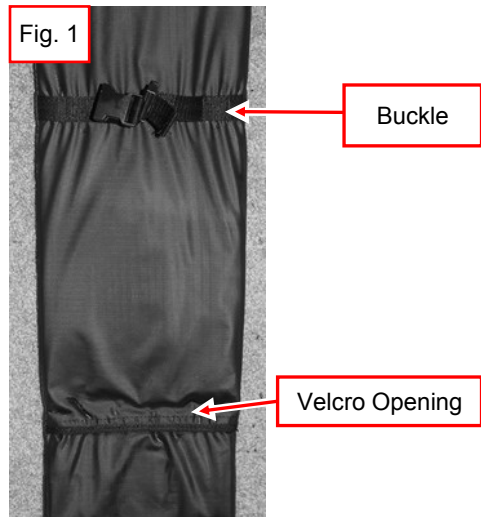
## Unpacking and Assembly

### What's Included:

- Eight (8) Vertical Pole Pad Covers
- Eight (8) Pad Foam Cores
- Instruction Manual

1. Remove all components from the packaging, and ensure that nothing is missing. Consult the list above, and if needed, contact JumpSport Customer Service at 1-408-213-2551.
2. Each pole pad cover has a Velcro-style opening on the back side (the side with buckles) (**Fig. 1**) and two pre-inserted foam pads with a space between the pads.
3. In the space between the two pre-inserted pads, insert an included foam core (**Fig. 3**) so it is flush with the pre-inserted pads and close the Velcro-style opening. One Vertical Pole Pad will be installed at each existing enclosure pole.
4. Position the pad vertically against the enclosure pole, so that the entire pole is covered by the pad. The Velcro-style opening should face towards the ground and against the pole. The top of the pad should be flush with the Octagon rods. (**Fig. 4**)
5. Connect the Pole Pads to the enclosure poles using the buckles on the back of the pole pads. Do not thread the buckles through the net (**Fig. 5**).

**Your JumpSport Vertical Pole Pads are now ready to use!**

You must pay freight and insurance to return the part to JumpSport. At JumpSport's sole discretion, we may ask you to send photographs in addition to or in lieu of returning the part.
- 3) After inspecting the returned part(s), JumpSport will make a final determination whether the part is covered by this warranty. We reserve the right to examine photographs or physical evidence concerning parts claimed to be defective prior to making a final determination concerning the claim. A repaired or replacement part will be returned to you. (Shipping charges may apply.) Please allow 3 to 4 weeks for delivery."
