

JumpSport® SunShade™ Trampoline Canopy User's Manual

Assembly Information. (Fits 12' and 14' round trampolines with safety enclosure)



Do not attempt or allow somersaults. Landing on the head or neck can cause serious injury, paralysis or death, even when landing in the middle of the trampoline.

DO NOT intentionally jump into or rebound off the canopy, pole pads, or enclosure net.

DO NOT hang from, kick, cut or climb on the canopy, pole pads, or enclosure net.

- **WARNING:** Carefully read, understand, and follow all of the warnings and instructions provided with your trampoline and enclosure.
- Trampolines over 20 inches (51 cm) tall are not recommended for use by children under 6 years of age.
- Limit bounce height to avoid coming into contact with the canopy. Do not bounce high.
- Use only in a well lit area by responsible, mature, non-intoxicated persons.
- Keep objects away which could interfere with safe use. Maintain adequate clearance underneath, above, and around the trampoline.
- Inspect before each use. Make sure the canopy is properly installed, with proper tension, and that all frame and pole padding on your trampoline and enclosure is correctly and securely positioned. Replace or adjust any loose, worn, defective, or missing parts.

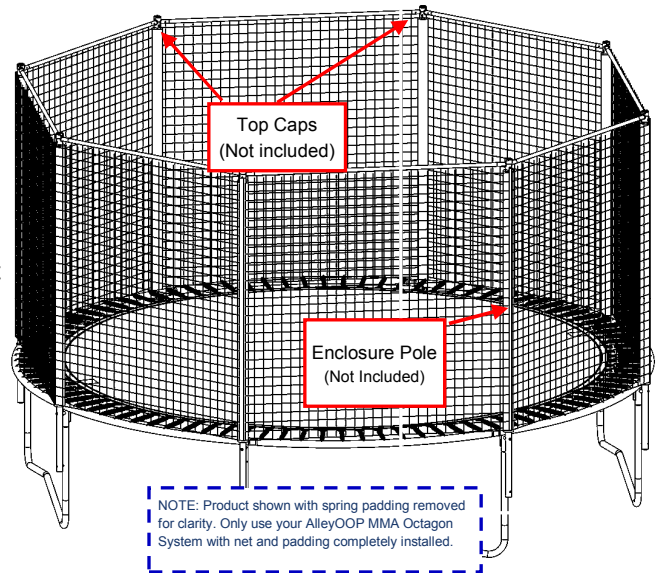

Unpacking and Assembly

What's Included:

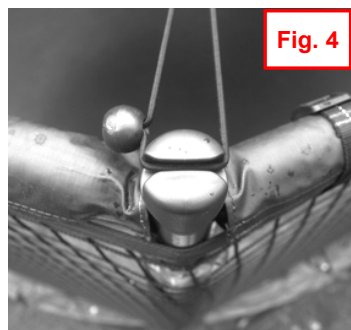
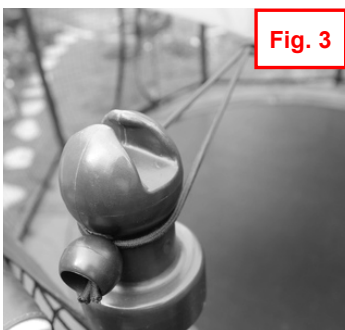
- Eight (8) bungees with ball ends
- One (1) Shade Canopy
- Instruction Manual.



1. Remove all components from the packaging, and ensure that nothing is missing. Consult the list above, and if needed, contact JumpSport Customer Service at **1-408-213-2551**.
2. Attach the bungee cords to the canopy by threading one through each of the eight loops around the circumference of the canopy. **(Fig. 1)**
3. While standing inside the trampoline, unfold the shade canopy until it is only folded once. Hang the canopy by two opposing bungees. **(Fig. 2)**
4. Loop the bungees over the ball end-cap, if you have a regular enclosure or JumpSport Elite Trampoline **(Fig. 3)**. Put the bungee through the slot on top cap of the enclosure pole if you have an Octagon kit installed. **(Fig. 4)** Those with 12' trampolines may need to shorten the bungees by knotting or wrapping extra length around enclosure poles.
5. Repeat step 4 at each of the enclosure poles. The shade should be evenly connected all the way around the enclosure. **(Fig. 5)**

You must pay freight and insurance to return the part to JumpSport. At JumpSport's sole discretion, we may ask you to send photographs in addition to or in lieu of returning the part.
- 3) After inspecting the returned part(s), JumpSport will make a final determination whether the part is covered by this warranty. We reserve the right to examine photographs or physical evidence concerning parts claimed to be defective prior to making a final determination concerning the claim. A repaired or replacement part will be returned to you. (Shipping charges may apply.) Please allow 3 to 4 weeks for delivery."
