

- Remove ladder when trampoline is not in use in order to prevent access by children under 6.


The following page contains diagrams and written instructions for installing your SureStep Trampoline Ladder.

Familiarize yourself with the Assembly and Installation Instructions before beginning installation.

Note: This SureStep Trampoline Ladder is designed to fit trampolines that are 33 to 37 inches tall.

#### Assembly and Installation Instructions





(Under side of step, showing square nut location)

Reference #	Description	Quantity
1	Step	2
2	Vertical side piece	2
3	Square nut	4
4	M6 screw, long	4
5	Horizontal base	1
6	M6 screw, short	2
7	Nylock nut, 10mm	2
8	Acorn nut	2

**Note:** You will need a Phillips screwdriver & and a 10mm wrench (not included) to install your SureStep Trampoline Ladder.

**1)** Slide steps into place along vertical side pieces. Install square nuts (see Diagram 2), then loosely tighten *long* M6 screws with a Phillips screwdriver.

**Note:** The top of each step is angled. The thinner side needs to face out (away from the hooked ends on the top of the vertical side pieces) and the thicker side needs to face in (toward the hooks).

**2)** Slide horizontal base into place. Then loosely tighten *short* M6 screws and Nylock nuts together, using a Phillips screwdriver and a 10mm wrench.

3) Tighten *long* (step) screws snugly. Do not over-tighten.

**4)** Tighten *short* (base) screws snugly. Do not over-tighten. Then hand-tighten acorn nuts over ends of screws.

**5)** After ladder is completely assembled, hook it over top rail of trampoline, under frame pad.

#### Your SureStep Trampoline Ladder is now complete!

You must pay freight and insurance to return the part to Jump-Sport. At JumpSport's sole discretion, we may ask you to send photographs in addition to or in lieu of returning the part.
- 3) After inspecting the returned part(s), JumpSport will make a final determination whether the part is covered by this warranty. We reserve the right to examine photographs or physical evidence concerning parts claimed to be defective prior to making a final determination concerning the claim. A repaired or replacement part will be returned to you. (Shipping charges may apply.) Please allow 3 to 4 weeks for delivery.

This warranty gives you specific legal rights. You may also have other rights which vary from state to state.
